I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On the above date and time, officers responded to several shots fired in the Pedestrian Mall. Officers were able to take Wilson into custody a short distance away and located two firearms near his person. During an interview, Wilson admitted to firing several rounds at other subjects. Three subjects were transported to a local hospital with gun shot wounds. One of the subjects, identified as Kaleek Jones, suffered a fatal gunshot wound and died on August 29th, 2017 due to the injuries.
