NARRATIVE

Narrative of Offense Committed

On or about the above stated date and time, the Defendant did
having malice aforethought, willfully, deliberately, and with premeditation kill Tommy Curry

AFFIDAVIT

STATE OF IOWA, JOHNSON COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On 4/28/2021, at approximately 2004 hours, multiple 911 calls were received reference a shooting at the Meadow Lark Apartment Complex (2400 Lakeside Drive, Iowa City, Johnson County, Iowa). TOMMY CURRY was located in his vehicle in the apartment complex parking lot. CURRY had been shot multiple times and his death was ruled a homicide.

Witnesses observed a male approach CURRY's vehicle and start shooting. Witnesses also observed a white SUV fleeing the scene. A review of CURRY's cellphone provided investigators with a text message conversation between CURRY and an unknown phone number. The messages between CURRY and this phone number began on 1/23/2021. Investigators determined CURRY met the owner of the phone number on the dating website. He believed the owner of the account to be a female. On 4/28/2021, CURRY agreed to meet the person whom he was texting with, leading CURRY to the Meadow Lark Apartments.

Investigators obtained records for the phone number texting CURRY and records from the dating website, which were linked to Renard WINFIELD JR. Further, the records indicated WINFIELD JR was posing as a female on the dating website.

Investigators located surveillance video from multiple sources showing a white Dodge Journey fleeing the scene of CURRY's murder. Location records were obtained from the cellphone carrier of WINFIELD JR's known phone number, which showed WINFIELD JR in the area of the murder.

Investigators located surveillance video of a white 2018 Dodge Journey; registered to a relative of WINFIELD JR. Surveillance video from multiple sources show this vehicle in Iowa City on 4/27/2021 and 4/28/2021. Surveillance video shows WINFIELD JR driving this vehicle on those dates.

WINFIELD JR's cellphone was seized from his person. A review of WINFIELD JR's phone revealed screenshots of CURRY's dating profile, a video of WINFIELD JR in possession of a handgun, which is believed to be the same caliber as the murder weapon used. WINFIELD JR was in possession of this handgun the day before the murder. A video also showed WINFIELD JR in possession of ammunition which was located on scene of the murder, and surveillance video showed WINFIELD JR purchasing the same ammunition days before the murder.

WINFIELD JR was interviewed, and he stated he hadn't been in Iowa City since the end of March, 2021. Further, he stated the white 2018 Dodge Journey had not been in Iowa City either.
