Narrative of Offense Committed
 On or about the above stated date and time, the Defendant did
 having malice aforethought, kill Jonathan Wieseler, while participating in a forcible felony, to wit: Robbery 1st Degree.

AFFIDAVIT

STATE OF IOWA, JOHNSON COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On April 22, 2017, between 10:20PM and 10:32PM, Curtis Cortez Jones caused the death of Jonathan Wieseler, by shooting him in the head with a small caliber firearm, without justification, during the course of committing Robbery in the 1st Degree, a forcible felony. Jones was captured on surveillance video within blocks of the crime scene on April 22, 2017, driving a vehicle that was later searched pursuant to a State of Iowa Search Warrant. Forensic testing identified the DNA of Jonathan Wieseler co-mingled with DNA of Curtis Cortez Jones, on evidence seized during the execution of that Search Warrant.
