

ALL BUSINESSES OPEN DURING CONSTRUCTION. PROVIDE A MINIMUM 8' WIDE WALKWAY ADJACENT TO BUILDING. 11' WIDE MINIMUM FOR FIRE TRUCK ACCESS ALONG EAST SIDE DUBUQUE STREET AS NOTED ON PLAN

GENERAL PHASING NOTES

PHASE 1 . PEDESTRIAN MALL DUBUQUE STREET CORRIDOR

- INSTALL 6-FOOT CHAIN LINK FENCE AND OTHER PEDESTRIAN TRAFFIC CONTROL DEVICES PROVIDING A MINIMUM 8' WALKWAY ADJACENT TO BUILDING FACE ON THE WEST SIDES AND 11' ON THE EAST SIDE OF DUBUQUE STREET WITHIN THE PEDESTRIAN MALL.
- 2. REMOVE SIDEWALK PAVEMENT AND OTHER ITEMS IDENTIFIED FOR DEMOLITION AS NEEDED TO COMPLETE WORK TO PHASING LIMITS.
- 3. INSTALL PEDESTRIAN TRAFFIC CONTROL CLOSING SIDEWALK AS REQUIRED DURING WATER SERVICE INSTALLATION.
- 4. INSTALL WATER MAIN. OBTAIN PASSING TEST(S).
- 5. INSTALL WATER SERVICES. MAINTAIN 8' PEDESTRIAN ACCESS TO BUSINESSES AT ALL TIMES. OBTAIN PASSING TEST(S).
- 6. INSTALL OTHER UTILITIES, PAVEMENT WITHIN PHASE LIMITS, PLANTER WALLS AND CURBS, LIGHTS AND OTHER IMPROVEMENTS WITHIN PHASE LIMITS. MAINTAIN 8' PEDESTRIAN ACCESS TO BUSINESSES AT ALL TIMES.
- 7. BRIDGING, SCHEDULING AND OTHER METHODS SHALL BE USED TO MAINTAIN BUSINESS ACCESS AT ALL TIMES. METHODS SHALL BE USED TO PROVIDE SECURITY AND WEATHER PROTECTION TO EXISTING BUILDING SPACES DURING VAULT REPAIR OPERATIONS.
- 8. CONSTRUCTION TRAILER TO BE RELOCATED AS NECESSARY.
- DURING ALL STAGES OF WORK, CONTRACTOR TO MAINTAIN AN AVERAGE OF .5 FC WITH TEMPORARY LIGHTING AT ALL AREAS ACCESSIBLE TO PEDESTRIANS, THAT ARE BEING USED, THROUGHOUT CONSTRUCTION. STYLE AND PROPOSAL FOR LIGHTING TO BE COORDINATED AND APPROVED BY CITY. IF NECESSARY AND APPROVED BY CITY, AREAS REQUIRING WORK AFTER DARK TO COMPLY WITH IDOT LIGHT LEVEL SPECIFICATIONS.

PHASE 1 ALLEY CRITICAL CLOSURE

14 ALLOWABLE CLOSURE DAYS

5 DAY TEMPORARY CLOSURE FOR UTILITY INSTALLATION ACROSS ALLEY

1) ONCE ALLEY IS CLOSED, IT IS TO REMAIN CLOSED UNTIL COMPLETION OF ALL WORK WITH THE EXCEPTION OF THE UTILITY INSTALLATION ACROSS THE ALLEY COVERED UNDER THE 5 DAY TEMPORARY CLOSURE. 2) WORK INCLUDES COORDINATION WITH MIDAM ON THERE INSTALLATION OF 2-INCH PLASTIC GAS MAIN WITHIN THE ALLEY AND ACROSS DUBUQUE ST.


