Narrative of Offense Committed

On or about the above stated date and time, the Defendant did unlawfully and intentionally attempt to cause the death of ____ and not under circumstances which would justify the person's actions, the person does any act by which the person expects to set in moti

STATE OF IOWA, JOHNSON COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On the above date and time the ICPD responded to shots fired on the 300 block of E. Court St. Police arrived on scene and found 2 people who had been shot. Subsequent investigation showed the def. and her brother in a verbal arguement with a group of 3 guys. The 3 guys leave the area in the opposite direction of the def. Seconds later video shows the def. and her brother chasing after the 3 victims. The def. and brother catch the victims on 300 E. Court St. and attack them. During the attack the victim pulls out a gun from her waistband and fires 6 shots at 2 of the victims. 6 .40 shell casings were found on scene. The def. strikes 1 victim with 1 shot, and accidentally shoots her brother twice. Both victims who were shot at thought they were going to die. The def. fled the scene and can be tracked via surveillance video all the way back to her residence. Police received tips that the def. was the shooter. Witnesses who know the def. identified her in the surveillance video. A search of the def. apartment found a .40 handgun and .40 ammunition.


