Narrative of Offense Committed

On or about the above stated date and time, the Defendant did have knowledge that public offense has been committed and whom committed said offense, and harbors, aids or conceals the person who committed the offense with the intent to prevent the apprehension of the person who committed the offense, said offense being a felony

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

The defendant's girlfriend shot at multiple people on 9-29-18. The defendant was stopped by police leaving her residence on 10-3-18. The defendant told police her girlfriend was not in the apartment. Police had constant surveillance on the apartment, and eventually observed the defendant's girlfriend exit the apartment. Subsequent investigation showed the def. was intentionally lying to police about girlfriend being inside. Investigation shows def. girlfriend went immediately to def. apartment after the shooting. The def. harbored/concealed her girlfriend after she committed the offense of attempted murder. Text communication was found between the def. and the person her girlfriend accidentally shot. This communication referenced him having surgery as a result of being shot. This proves def. had knowledge of the shooting. Blood was also found all over the inside of the defendant's apartment that is believed to be related to the shooting on 9-29-18.


