The def. harbored/concealed her girlfriend after she committed the offense of attempted murder. Text communication was found between the def. and the person her girlfriend accidentally shot. This communication referenced him having surgery as a result of being shot. This proves def. had knowledge of the shooting. Blood was also found all over the inside of the defendant's apartment that is believed to be related to the shooting on 9-29-18.
