On the above date and time, the defendant was eastbound in the 300 block of E. Burlington Street in his 1998 Toyota Camry (JCK193), and was stopped behind other vehicles due to a protest in the intersection ahead of him. Bystander video shows the defendant honking, and eventually making a U-turn while squealing his tires to turn around. The def. shut off his lights, and drove around the block, where he chose to turn southbound on Gilbert St. where there were no vehicles between him and the protesters. The defendant intentionally struck multiple protesters with his vehicle and sped away eastbound on Burlington St. The defendant said the protesters needed "an attitude adjustment." One victim has been identified and complained of pain due to being struck intentionally by the defendant's vehicle.
